SEND GREETING:

WHEREAS, I, the said Katie Vanadore  
in and by a certain promissory note in writing, of  
even date with these presents, am well and truly indebted to

in the full and just sum of Two Hundred twenty seven and 56/100

Dollars, to be paid 6 months from date per the givers request  
changed to thirty day note to a six months  
note

with interest thereon from date of signing until paid at the rate of eight per cent. per annum to be  
computed monthly

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue  
thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10% of amount due

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I the said Katie Vanadore  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said Thomas F. McAfee,

his heirs and assigns, all that lot of land situate  
near the City of Greenville, in the County and  
State aforesaid, being a sub-division of the Morgan  
Hill Addition as shown on plat made by  
W. A. Hudson, D. S., March 8, 1904, and described  
as follows:

Beginning at a stake on the south side of Summit  
Street 171 feet 10 1/2 inches from the corner of  
Summit and Parker Streets, and runs thence  
with Summit Street N. 83 3/4 E 103 feet 1 1/2 inches to an  
iron pin; thence S 13 W 160 to an iron pin; thence  
S. 83 3/4 E 77 feet 3 inches to a stake; in a northerly  
direction 156 feet, more or less, to the beginning of the  
said conveyance, said conveyed to me by J. B. Hudson  
by deed dated the first day of May  
1920, and recorded in vol. 58, page 223.
