day of ^{May} 25th 1921 ^{at 3% per annum} \$3,500.00 on or before May 25, 1921

with interest from Date

at the rate of 3 per centum per annum until paid; interest to be computed and paid annually

and if unpaid when due to bear interest at same rate as principal until paid, and I have further

promised and agreed to pay to her cent. of the whole amount due for attorney's fees, to be collected by an attorney or through legal proceedings of any

kind, reference being hereunto had when and fully appear.

NOW, KNOW ALL MEN, That I

in consideration of the said debt and sum of money aforesaid, and for the better

securing the payment thereof according to the terms of the said note and also in consideration of a further sum of Three Dollars to me

in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and

released, and by these presents do grant, bargain, sell and release unto the said Edna E. Willis

all that piece, parcel, tract or lot of land situated in Greenville

Township, Greenville County, State of South Carolina,

near Judson Mills on the north side of the Casley
 Bridge Road known as lot 9, on Plat of West High-
 land recorded in Office of R. M. C. for said County
 in Plat book, C, Pages 258-259 having the following
 courses and distances according to said Plat:
 Beginning at a stake on the north-west corner of
 Georgia Avenue, and the Casley Bridge Road, said
 stake being 229.1 feet wide of the side of the right
 of way of the Piedmont and Northern Railroad and
 running thence with Georgia Avenue (a 50 foot St.)
 N. 9.30 W. to stake corner of Georgia Avenue and
 Gordon Street; thence with Gordon Street (a 50 foot St.)
 S. 71 W. 700 feet to stake corner of Gordon Street and
 Florida Avenue; thence with Florida Avenue (a 50
 foot street) S. 7.30 E. 710 feet to stake on Casley Bridge
 Road; thence with Casley Bridge Road N. 71 E. 400
 feet to the beginning, containing 8 acres more or less
 being one of the lots conveyed to Edna E. Willis by N. H.
 Harris et al by deed dated January 28th 1916, re-
 corded in Book 57, Page 464 in said R. M. C. Office.
 It is understood and agreed that the mortgagee
 shall release from the lien of this mortgage any
 portion of the lands covered by it upon payment
 to her by the mortgagor of not less than twelve
 hundred dollars per acre for the lands so released
 the said payment to be applied to the principal
 of the debt hereby secured, and interest upon the
 amount so paid on principal shall cease as of
 the date of payment.
