in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note, and also in consideration of the further sum of Three Dollars to me

in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Madge G. Harris

all that piece, parcel, tract or lot of land situated in Greenville Township, Greenville County, State of South Carolina,

known and designated as lot # 84 upon the plat of the Poinsett Realty Company, made by R. C. Dalton, Engineer, July 1919, which plat is recorded in the R. M. C. Office in and for Greenville county in Plat Book E, Page 137, said lot being more particularly described as follows: Beginning at a stake on the West side of Capers Street, at the corner of lot # 83, and running thence along line of lot # 83 S. 84.19 W. 175 feet to a stake at the corner of lots Nos. 83 & 84 thence S. 41 E. 70 feet to a stake at joint corners of lots Nos. 84 and 85; thence along line of lot No. 85 N. 84.19 E. 175 feet to a stake on Capers Street; thence along Capers Street N. 5. 41 W. 70 feet to the beginning corner, being the same lot of land purchased from the Poinsett Realty Company by the said Madge G.
