About thirteen miles south of the city of Greenville on the Greenville and Woodruff Road, being known and designated upon a plat of J. M. Silgore Land as Tract No. 6 and having the following metes and bounds, to wit: Beginning at Maple at bend of Gilders Creek, running thence north westerly 851 feet to corner, Greenville, Woodruff Road; thence along said road S. 81-09 E. 355 feet to bend thence S. 80-55 E. 900 feet to bend; thence S. 69 E. 164 feet to corner; thence leaving said road and running S. 6-58 E. 1562 feet to stake; thence S. 68-30 W. 270 feet to stake thence S. 72-30 E. 326 feet to stake; thence S. 84-30 W. 3887 feet to stake; thence S. 13-35 W. 550 feet to S.
