promised and agreed to pay ten per cent. of the whole amount due for attorney's fees, if said note collected by an attorney or through legal proceedings of any
kind, reference being hereunto had will more fully appear.

NOW, KNOW ALL MEN, That I *Richard Scott*

in consideration of the said debt and sum of money aforesaid, and for the better
securing the payment thereof according to the terms of the said note and also in consideration of the further sum of Three Dollars to me
in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and
released, and by these presents do grant, bargain, sell and release unto the said *Gladys F. Smith*

all that piece, parcel, tract or lot of land situated in *Greenville*
Township, Greenville County, State of South Carolina, *Beginning at an iron pin on the road which faces the*

Southern Railway Track, and running thence S. 85-1/2 E. one hundred forty feet with said
road to a stone 3x6 on line of Polly Austin; thence with her line and beyond S. 14 E.
five hundred fifty-nine and one-half feet to line of lot set off to Emma Butler; thence with
her line N. 81-3/4 W. one hundred forty-two feet to a stake on Sally Brown's line and
thence with Sally Brown's line N. 14 W. five hundred fifty-one feet to beginning corner.
This lot is about two and one-half miles west of Greenville Courthouse, and is the same
conveyed to me by Victoria Scott Carter, et al. by deed dated June 4, 1910, recorded in Book
10, page 86.

Also all that other lot of land in the Township, County and State aforesaid, near the
incorporate limits of the City of Greenville, in what is known as Stradleyville, being a
portion of lot No. 4 of the estate of Robert Scott, deceased, as shown on plat made by W.A.
Hudson, and recorded in Plat Book A., page 147: Beginning at a stake corner of lot of A.C.
Davis and lot set apart to Robert Scott and running thence N. 29 E. 76-1/2 feet to stake;
thence N. 61 W. 151 feet to stake; thence S. 29 W. 98 feet to stake; thence S. 61 E. 60
feet more or less to line of A.C. Davis; thence with her line N. 57-1/2 E. 28 feet to stake;
thence S. 60-1/2 80 feet, more or less to the beginning, being the same conveyed to me by
William Scott et al. by deed dated April - - 1910, and recorded in Book 10, page 87.
