in hand well and truly paid and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *H. Endel*

all that piece, parcel, tract or lot of land situated in *the city of Greenville, Ward Four* Greenville County, State of South Carolina, *having the following metes and bounds according to a survey*

and plat made by R.E. Dalton, which plat is recorded in Plat Book E., page 60: Beginning at an iron pipe on Falls St., corner of lot owned by Phillips and running thence with Falls Street N. 19.45 E. 66.3 feet to a fence; thence with the line of said fence S. 70.35 E. 90 feet to an iron pipe on a ten foot alley; thence with said alley S. 19.45 W. 91.7 feet to Webster St; thence with Webster St. N. 70.15 W. 10 feet to an iron pipe corner of Phillips lot; thence with the rear line of his lot N. 19.45 E. 25 feet to an iron pipe; thence with his line N. 70.15 W. 80 feet to the beginning corner; being the same lot of land conveyed to me by R.K.
