Township, Greenville County, State of South Carolina,

Containing ninety-nine and one-half acres, more or less lying on Glassy Mountain Road. Also the West tract, adjoining the above, containing 7.98 acres on South side of Public road leading from Gowanville to Glassy Mountain. Both of said tracts were conveyed to me by W. J. Roach, by deed dated October 25, 1920, recorded in Book 71, Page 226, reference to which deed is hereby made for a more particular description.
