Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim, the same or any part thereof.

And I... the said mortgagor, agree to insure the house and buildings on said land for not less than... 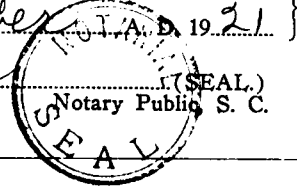
