all that piece, parcel, tract or lot of land situated in Butler

Township, Greenville County, State of South Carolina, and described as follows:

- Tract No. 1 on Little Rocky Creek of Enoree River containing sixty-eight and one-half (68-1/2) acres, more or less;
- Tract No. 2, situate on waters of Rocky Creek of Enoree River, containing forty (40) acres, more or less. The above two tracts having been conveyed to me by Corrie P. Bramlett and Joe Lee Bramlett by deed dated December 5, 1910, recorded in R.M.C. Office for Greenville County, S.C. in Vol. II, page 261. Reference being made to said deed for a full description by metes and bounds of said tracts of land.
- Tract No. 3 on waters of Rocky Creek and waters of Enoree River adjoining lands of V. Harbin A.B. Montgomery and others, and being tract No. 2 in the division of the Armsted King land, containing thirty-seven and three-fourths (37-3/4) acres, more or less.
- Tract No. 4, bounded by lands of Montgomery, Rector and others, containing Six and 56/100 (6.56) acres, more or less. The two tracts last above described having been conveyed to me by A.L. Henderson by deed dated December 24th, 1919.
