thence N. 13.36 E. 66.6 feet to a pin; thence N. 57.25 E. along
joint lines of lot no. 52 182 feet to a pin on Purman
Road; thence along said Purman Road N. 13.36 W. 60 feet and
5 inches 147.140 feet running corner being the same lot con-
veyed to me by J. A. Daniel by deed dated August 4, 1920
