Simpson*, Engineer, in Plat Book C, page 137, said lot being more particularly described as follows: Beginning at a stake on the west side of Capers Street at corner of lot No. 82, and running thence with line of lot No. 82 and S. 84-19 1/2 ft. 175 feet to a stake at corner of lot No. 82 and S. 83; thence S. 5 1/2 E. 70 feet to stake corner of lot No. 83 and S. 84; thence with line of lot No. 84 N. 84-19 1/2 E. 175 feet to stake on Capers Street; thence, with Capers Street N. 5 1/2 E. 70 feet to the beginning, Subject, however, to the restrictions and conditions contained in deed of *W. C. Simpson* dated March 2nd, 1920, and recorded in Deed Book 64, page 322.
