on the Laurens Hill Road, having the following metes
and bounds, to wit: Beginning at a rock corner in
the middle of the Laurens Road thence N. 19 $\frac{1}{2}$ E. 18 rods
ches. to a rock; thence S. 25 $\frac{1}{2}$ E. 17.25 ches. to a rock corner
in the middle of the Laurens Hill Road thence along
said road S. 77 $\frac{1}{2}$ W. 11.50 ches. to intersection of Laurens
Road thence along Laurens Road N. 68 W. 2.12 ches. to
beginning corner containing 1.6 acres more or less.
