any time fail to do so, then the said mortgagee may cause the same to be insured in its name and reimburse itself for the premium and expense of such

And if I shall make default in the payment of the said weekly interest as aforesaid, or shall fail  
to keep the buildings on said premises insured as aforesaid, or shall make default in any of the aforesaid stipulations for the space of thirty days, or shall  
be a member of said Association, then, and in such event I hereby assign the rents and profits

Court of said State may, at chambers or otherwise, appoint a receiver, with authority to take possession of said premises and collect said rents and profits,  
the net proceeds thereof (after paying costs of collection) upon said debt, interest, costs, expenses, attorney's fees and all claims then due the Association  
said mortgagor, without liability to account for anything more than the rents and profits actually collected.

PROVIDED ALWAYS, Nevertheless, and it is the true intent and meaning of the parties to these presents, that if I

pay prior encumbrance, shall be added to and constitute a part of the debt hereby secured, and shall bear interest at same rate.

and it is agreed by and between the said parties that the said mortgagor is
