the full and just sum of Thirty-eight Hundred (\$38.00.00)

DOLLARS,

to be paid on or before the date when the 28th Series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if I fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

the County and State aforesaid, near the City of Greenville on the north side of Cateechee Road, and being better known and designated as Lot No. 77 of the Cherokee Park sub-division and having according to a plat of said subdivision the following metes and bounds, to-wit: Beginning at an iron pin on the North side of Cateechee Road, the joint corner of Lots Nos. 78 and 77, and running thence with the northern side of said road S. 71-45 W. 60 feet to an iron pin, the joint corner of Lots Nos. 76 and 77; thence with the joint line of the last mentioned lots N. 15 W. 186 feet to an iron pin in line of S.C. Mills property; thence with line of S.C.
