That certain lot of land situated on the east side of Summer St. in the City of Greenville, designated as lot No. 6, in Block "A" of a certain plat recorded in plat Book "A" page 99 of the R. M. C. of Greenville County according to survey made by Lackwood, Greene & Company in May, 1905, said lot being the following lines & courses said distances to-wit:
Beginning at a stake on Summer Street corner of lot No. 7, thence with Summer Street N. 16-20 E. 52.375 to stake corner of lot No. 5, thence with line of lot No. 5 S. 75-30 E. 193.93 feet to stake on 20 foot alley, thence with 20 foot alley P. 17.00 W. 51.17 to stake corner of lot No. 7, thence with line of lot No. 7 N. 75-30 W. 193.47 feet to the beginning corner.
