WHEREAS, I, the said D. E. Shealy

in and by my certain promissory note in writing of even date with these presents am
well and truly indebted to GREENVILLE BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in
the full and just sum of Thirty-five hundred (\$3500.00)

DOLLARS,

All that piece, parcel or lot of land situate, lying and being in the city of Greenville, County and State aforesaid, lying on the north side of East Earle Street, and known as Lot No. 26 of section "F" on Plat of Stone Land Company, made by J. E. Sirmine, Engineer, and recorded in the N. M. S. Office for Greenville County in Plat Book "A", page 337, and is described as follows: Beginning at an iron pin 360 feet from the east side of Bennett Street, and running thence S. 71-20 E. with said Earle Street 60 feet to a stake; thence N. 18-30 E. 200 feet to a stake; thence N. 71-20 W. 60 feet to a stake; thence S. 18-30 W. 200 feet to the beginning corner of said Earle Street.
