lying, being and situated in the County and State aforesaid being described as follows:
Beginning at an iron pin on the east side of Faris Road, joint corner of lots 100 and 101 and running thence with the joint line of said lots S. 71-35 E. 151.8 ft. to an iron pin, joint corner of lots 82, 83, 100 and 101; thence with joint line of lots 83 and 100; N. 21-35 E. 50 ft. to an iron pin, joint corner of lots 83, 84, 99 and 100; thence with joint line of lots 99 and 100, N. 71-35 W. 156.3 ft. to an iron pin on east side of Faris Road; thence with the eastern side of Faris Road S. 16-30 W. 49.96 ft. to the beginning point.
