the full and just sum of Three thousand 3,000.00

DOLLARS,

to be paid on or before the date when the SI Series of the Capital Stock of the said GREENVILLE BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if SI fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being hereunto had, will more fully appear.

County, State of South Carolina, in the City of Greenville, on the West side of Robinson Street, having the following courses and distances: Beginning at an iron pin on the west side of Robinson Street 260 feet N. 1.50 E. from Earle Street at corner of lot No. 4 on plat hereinafter referred to, and running thence with line of said lot No. 4, N. 85.25 W. 100 feet to an iron pin in line of Stone property; thence with Stone line N. 1.50 E. 50 feet to an iron pin, corner of lot No. 6; thence with line of said lot S. 85.25 E. 100 feet to an iron pin on Robinson Street; thence with Robinson Street S. 1.50 W. 50 feet to the beginning.
