and ten per cent. in addition as an attorney's fee in case the same is collected by an attorney or by suit, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said *G. W. Bridwell*  
in consideration of the said debt and sum  
of money aforesaid, and for the better securing the payment thereof to the term of the said *W. G. Howard*  
according to the term of the said *note*

at and before the sealing and delivery of these Presents, the receipt  
whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

*W. G. Howard his heirs and assigns, all that tract of land situate at Traveler's Rest in the County and State aforesaid aforesaid being known as Tract 1101 of the estate of J. D. Cooper, deceased, according to a plat of 13 1/4 Acres, October 30, 1915 beginning at the intersection of Cooper and Church Streets and running thence S. 134 1/2 W. 1/4 3 to corner of lot of Baptist Church; thence N. 41 1/2 E. 4.77 to stone; thence S. 49 1/2 E. 3.17 to point on M<sup>e</sup> Alabama Road; thence along said road N. 41 E. 3.14 to point on said road, corner of lot of J. H. and J. C. Roe; thence along line of said J. H. and J. C. Roe N. 49 W. to corner of said J. H. and J. C.
