in hand well and truly paid by the said *M. A. Breageale*

at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

*M. A. Breageale her heirs and assigns, those two certain tract of land situate in the county and State aforesaid, known and designated as Tracts nos. 5 and 6 on plat of the Goldsmith and Agnew Farms, containing 25 acres more or less, and described as follows: Tract No. 5. Beginning at a point on "Long Branch" corner Tract no. 6, and runs thence with line of said tract N. 55.45 E. 1243 to point in middle of road; thence with said road in a northwestern direction 427 to point corner of lands of Dr. Ware; thence with said Ware lands S 59.35 W. 1161 to iron pin on "Long Branch"; thence with meanderings of said "Long Branch" in a southeasterly direction 492 to the beginning corner containing 13 acres, more or less.*

*Tract no. 6. Beginning at a point joint corner of Tracts nos. 6 and 7, and runs thence N. 44.15 E. 1225 to point in road; thence in a northwesternly direction 300 to point in road, joint corner of Tracts nos. 5 and 6; thence along line of Tract no. 5 S. 55.45 W. 1243 to point on "Long Branch" joint corner of Tracts nos. 5 and 6; thence with meanderings of said "Long Branch" in a southeasterly direction 528 to the beginning corner, containing 12 acres, more or less.*
