AND IT IS AGREED, by and between the said parties, that the said J. D. Glazener will to hold and enjoy the said Premises until default of payment shall be made.

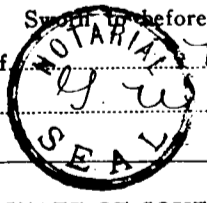

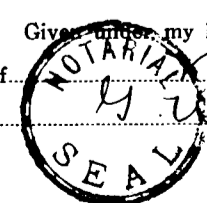
