TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Elizabeth Davenport,

SEND GREETING:

WHEREAS, I the said Elizabeth Davenport,

in and by my certain promissory note, in writing, of even date with these presents, well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., in the full and just sum of One thousand, Five Hundred & no/100

(\$ 1,500.00 ) Dollars,

with interest at the rate of six (6%) per centum per annum, to be repaid in installments of Fifteen and no/100

(\$ 15.00 ) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid; said monthly payments shall be applied first to the payment of interest computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note shall at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for a reasonable attorney's fee, besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which are secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, that I the said Elizabeth Davenport,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said Elizabeth Davenport, in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in the City of Greenville, on the east side of McCall Street, and being known and designated as a portion of Lot No. 40, as shown on plat of the lands of T. E. Ware estate, as shown by plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "A", at Page 270, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the east side of McCall Street, at a point approximately 368.5 feet from the northeast intersection of Rhett Street and McCall street, at corner of 25' (twenty five feet) lot said by Jane E. Kellett to Jesse T. Wood, and running thence along the line of that lot N. 70 E. 190.08 feet to an iron pin; thence in a northerly direction parallel with McCall Street 89.84 feet to an iron pin, rear corner of Lot No. 39; thence S. 70 W. 190.08 feet to an iron pin on McCall street; thence in a southerly direction along the line of McCall street 89.84 feet more or less to the beginning corner. Being all of Lot No. 40 of the property of the T. E. Ware estate, except that part thereof conveyed by Jane E. Kellett to Jesse T. Wood April 2, 1907, by deed recorded in the R. M. C. Office for Greenville County in Vol. VVV, at page 147, the same having a frontage on McCall street of 25 feet, and running back in parallel lines the entire depth of said lot. This is the same lot conveyed to me by Peoples National Bank, Executor of the estate of D. D. Davenport, deceased, by deed not yet recorded."
