NOW KNOW ALL MEN, That the said Mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee, according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor, in hand well and truly paid by the said Mortgagee, at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain and release unto the said Mortgagee, and

her Heirs and Assigns, forever, all and singular that certain piece, parcel, lot or tract of land situate, lying and being in *Dunklin Township, Greenville* County, State aforesaid,

containing ninety-four and one-twenty-fifth (94-1/25) acres, more or less, having the following metes and bounds, to-wit:

Beginning at a stone near a branch, thence running S. 32 1/2 W. 16.69 to a pine; thence S. 71 E. 12.40 to a stone on Dunklin Bridge road; thence along said road 2.50 to a stone; thence crossing said road 36 1/2 E. 6.65 to a stump; thence N. 73 3/4 E. 14.74 to a stone; thence S. 12 E. 5.13 to a stone; thence N. 6 1/2 E. 15.00 to a stone; thence N. 25 E. 15.77 to a stone on a branch; thence up the branch to the beginning corner, being tracts Nos. 1, 2, and 5, and the home tract of William Sims.
