All that certain piece, parcel, or lot of land situated lying and being in the state and county aforesaid, in the Town of Greenville, on the north side of Hubert Street, and having the following lines and bounds to wit

Beginning at a stake on the north side of Hubert Street - C. W. Drace corner and running thence along Drace's line 181 feet to iron pin on W. S. Hudson's line, thence along said Hudson's and Boyce De Young's line 62 $\frac{1}{3}$ feet to an iron pin, W. T. Neeson's corner. Thence with said Neeson's line S. 16 $\frac{1}{2}$ W. 174 feet to a stake on the edge of Hubert Street.
