computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, and note further providing for an attorney's fee of ten per cent on the amount due besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

grant, bargain, sell and release unto the said Lawl R. Zimmerman

All that certain piece, parcel or lot of land situate, lying and  
being in the State and County aforesaid, in ward side of the  
City of Greenville, having the following metes and bounds, to-wit: begin-  
ning at an iron pin on the south side of Atwood Street, corner of  
lot #7 and running thence with line of lot #7 S. 42-0 E. 159 feet  
to a stake in Marshall line thence S. 48-0 W. 65 feet to a  
stake thence N. 42-0 W. 159 feet to Atwood Street thence with  
Atwood St. N. 48-0 E. 65 feet to the point of beginning. and being  
known as lot #6, on plat of the property of Lawl R. Zimmerman  
& Ferris M. Williams, which plat is recorded in the R. M. C. office  
for said County in Plat Book "C" at page 132. This being the same
