thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference

grant, bargain, sell and release unto the said Mollie Gilstrap, and her heirs and assigns, All that lot

Township of Greenville, near Monaghan Mills, and being a part of the lands known as
Riverside; said lot being known and designated as Lot #5 in Block CC, on a plat
of Riverside Land Co., which plat is recorded in plat book A., at page 323, and
having a frontage of 65 feet on Colonial Avenue and a depth of 131.4 feet on
