WHEREAS, I, Mary Weaver, the said Mary Weaver
in and by my certain PROMISSORY note in writing, of
even date with these presents, a.m. well and truly indebted to

V.M. Babb of Mountain Inn
in the full and just sum of Five hundred fifty and no/100
Dollars, to be paid on or by the first of November 1922

with interest thereon from maturity at the rate of 8 per cent. per annum to be
computed and paid annually in advance

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per cent besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do

grant, bargain, sell and release unto the said V.M. Babb, his heirs and assigns, The following

described eight parcels or lots of land all lying and being situate in the Town of Fountain
Inn and in Greenville County, State of South Carolina, to-wit:
Lot #26 in block 2, containing 50 by 202 feet upon which my residence is situated.
Also three lots of land #s 22,23, and 24 in block 1, containing 50 by 202 feet in each lot,
situate on the west side of Shaw Street.
Also three lots of land #s 42,43 and 44 in block 4, containing 50 by 150 feet in each lot.
Also that other lot of land #41 in block 4, being 50 feet wide and 150 feet deep, bounded
by Shaw Street, Butler Avenue and the foregoing described lots, all of which are of the
subdivision of the lands of the Fountain Inn Manufacturing Company, which are more fully
described in a deed from M.E. & G.B. Rents to B.B. Edwards & J.H. Knight, said deed being
