until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do

grant, bargain, sell and release unto the said Jones McCrorey, his heirs and assigns, all that lot of
land situate in Greenville Township, County and State aforesaid, being a part of what is
known as Buist Circle Property, and more fully described herewith:

This property having the following metes and bounds to-wit: Beginning at an I.P. 3X
on the S. side of Mountain View Avenue, and being the joint 3X of lots #8 & 9 and runs
thence with line of said lots S. 30 W. 189.5 feet to I.P. 3X. the common corner of lots
#8, 9, 17 & 18; thence N. 65-30 W. 100 feet to I.P., the common corner of lots #7, 8
16 & 17; thence N. 30 E. 189.5 feet to I.P. on Mountain View Avenue; thence S. 65-30 E.
100 feet to the beginning 3X, and is known as lot #8, including one-half of alley in the
rear of said lot as shown plat made by W.D. Neves, Eng. dated June 1, 1911 and is
recorded in plat book E, page 105.
