interest each month hereafter from date until paid in full said amount to be paid  
on the tenth day of each subsequent month.

with interest thereon from date as stated above at the rate of 8 per cent. per annum to be  
computed and paid -

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid when the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage, said note further provides for an attorney's fee of

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do

grant, bargain, sell and release unto the said S.L. McBee, all of that certain piece, parcel, tract or

lot of land situate, lying and being in Greenville Township, State and County aforesaid  
and being lot number twenty-four (24) of Tract number three (3) known as "Hillside Heights"  
of the Overbrook subdivision according to survey and plat of R.E. Dalton, C.E., September  
1921 and having the following metes and bounds, to-wit:  
Beginning at a stake on the Southern side of Circle Street and running thence S. 15-53  
W. (along the back lines of lots 25 and 26) 150 feet to a stake; thence S. 72-17 E. 72  
feet to a stake; thence N. 11-22 E. 150 feet to a stake on the southern line of Circle  
Street; thence westwardly along the Southern line of Circle Street 60 feet, N. 71-17 W.
