I, Rena Tillman of the State and County aforesaid SEND GREETING:

WHEREAS, I, the said Rena Tillman
in and by E. E. Stone certain promissory note in writing, of
even date with these presents, am well and truly indebted to

in the full and just sum of Five hundred fifty and no/100
Dollars, to be paid \$250.00 on January 17th, 1923 and \$300.00 on July 17th, 1923

with interest thereon from July 17th, 1922 at the rate of 8 per cent. per annum to be
compounded and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who

is bound thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent of amount due hereon besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference
being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I the said Rena Tillman
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

in hand well and truly paid by the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do
grant, bargain, sell and release unto the said E. E. Stone, All that certain piece, parcel or lot of land

situate, lying and being in the County and State aforesaid in Ward Two of the City of
Greenville on the South side of East Stone Avenue 62 feet from the southeast corner of
Stone Avenue and Venny Street and running thence with Stone Avenue S. 71-50 E. sixty-two
feet to a stake; thence S. 20-19 W. one hundred seventy-five feet to a stake; thence N. 71-
50 W. sixty-two feet to a stake; thence N. 20-19 E. one hundred seventy-five feet to the
beginning corner on Stone Avenue, and being lot #25 of Section H. of a plat of Stone
Land Company, said plat being on record in the office of the R.M.C. for Greenville County
in Plat Book A., at pages 337 to 345 and being the same lot conveyed to me the said Rena-
Tillman by the said E. E. Stone by his deed dated July 19th, 1922.
It is understood and agreed by and between the grantor and grantee of this mortgage that
the same is junior to a mortgage this day executed to the American Building and Loan
Association in the sum of three thousand Dollars.
