interest be at any time past due and unpaid, then the whole amount evidenced by said note, to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten per centum besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference

grant, bargain, sell and release unto the said The Woodside National Bank, All that certain piece, parcel or

lot of land, situate, lying and being in the State of South Carolina, County of Greenville
and in the City of Greenville and on the north side of East Avenue in said City, said
property being described by metes and bounds as follows:
Beginning at a pin on the north side of East Avenue, fifty-one feet and eight inches
from the corner of McGee Street, joint corner of the lot owned in 1920 by B.P. Woodside, and
running thence North 21 degrees 45 min. West with the line of the lot of said B.P. Woodside
One hundred fifty-five feet to a pin on a ten foot alley; thence South 80 degrees West
fifty-one feet and eight inches to a pin, joint corner of the lot owned in 1920 by T.P. -
Carson; thence South 21 degrees 45 min. East one hundred fifty-five feet with the line of
T.P.P. Carson to a pin on East Avenue; thence with said East Avenue North 80 degrees East
fifty-one feet and eight inches to point of beginning.
