

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, W. S. Buchanan, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said W. S. Buchanan in and by my certain bond or obligation, bearing date the 19th day of March 1921, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Forty - Two Hundred + no/100 (\$4200.00) Dollars,

conditioned for the payment of the full and just sum of Twenty - one + no/100 (\$2100.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 18th day of March A. D. 1921 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say,

that I the said W. S. Buchanan shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of March 1921, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum of Thirty - Five + no/100 (\$35.00) Dollars (\$21.00 Dollars,

being the regular monthly installment payable on the twenty one shares of stock and Fourteen + no/100 (\$14.00) Dollars,

being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Thirty - Two + 20/100 (\$32.20) Dollars (\$21.00 Dollars,

being the regular monthly payment on said stock and Eleven + 20/100 (\$11.20) Dollars being the monthly interest on balance due); for the next twenty months the sum of Nine + 40/100 (\$9.40) Dollars,

(\$21.00) Dollars being the regular monthly payment on said stock and Eight + 40/100 (\$8.40) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Twenty - six + 60/100 (\$26.60) Dollars (\$14.00) Dollars,

being the monthly payment on said shares of stock and Twelve + 60/100 (\$12.60) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Twenty - six + 80/100 (\$26.80) Dollars,

(\$14.00) Dollars being the monthly payment on said shares of stock and Twelve + 80/100 (\$12.80) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance, and in the said W. S. Buchanan and shall pay or cause to be paid, all fines which may be imposed upon, or charged against me, the said W. S. Buchanan in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN that I, the said W. S. Buchanan in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said W. S. Buchanan in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

All that certain lot of land in Greenville, Township, Greenville County, South Carolina, about one and one-half miles northwest of Greenville County Court House and being lot No. 14 of a sub-division of land known as Norwood Heights, according to a plat recorded in Plat. Book W, page 133 R. M. C. Office for Greenville County and being the same lot conveyed to me by W. M. Norwood, deed recorded in said R. M. C. Office in deed book 44, page 365. Said lot has the following metes and bounds:
Beginning on Southwest corner of main and Vance streets running thence with main street N. 74 W. 150 feet; thence S. 9 3/4 W. 55 feet. thence S. 74 E. 150 feet to Vance Street. thence with Vance Street N. 9 3/4 E. 55 feet to the beginning corner.
