

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mrs. G. C. Perry, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said Mrs. G. C. Perry in and by my certain bond or obligation, bearing date the 31st day of March 1921, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Two Thousand + no/100 (\$2000.00)

conditioned for the payment of the full and just sum of One Thousand + no/100 (\$1000.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 31st day of March

being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Fifteen + 33/100 (\$15.33) Dollars

being the regular monthly payment on said stock and Five + 33/100 (\$5.33) Dollars being the monthly

interest on balance due); for the next twenty months the sum of fourteen (\$14.00) Dollars,

( \$10.00) Dollars being the regular monthly payment on said stock and

the sum of four (\$4.00) Dollars being the monthly interest on balance due); for the next twenty months pay

being the monthly payment on said shares of stock and Twelve + 67/100 (\$12.67) Dollars (\$10.00) Dollars,

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said

ment upon the advance or loan made me, the said Mrs. G. C. Perry and shall pay or cause to

be paid, all fines which may be duly imposed upon, or charged against me, the said Mrs. G. C. Perry

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition hereunder written, reference being

thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Mrs. G. C. Perry in consideration of the said debt

and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the

condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said
