

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Joe Gregg, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said Joe Gregg in and by my certain bond or obligation, bearing date the 26th day of April 1921, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of One thousand + no/100 (\$ 1,000.00)

conditioned for the payment of the full and just sum of Five Hundred + no/100 (500.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 26th day of April A. D. 1921 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I the said Joe Gregg shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville, City aforesaid, monthly, on the 20th day, or before the end of the month of April 1921, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum

Eight + 33/100 (\$ 8.33) Dollars (\$ 5.00) Dollars, being the regular monthly installment payable on the five shares of stock, and Three and 33/100 (3.33) Dollars being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Seven and 67/100 (7.67) Dollars (\$ 5.00) Dollars, being the regular monthly payment on said stock and Two + 67/100 (\$ 2.67) Dollars being the monthly interest on balance due); for the next twenty months the sum of Seven + no/100 (\$ 7.00) Dollars, (\$ 5.00) Dollars being the regular monthly payment on said stock and Two + no/100 (\$ 2.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Six + 33/100 (\$ 6.33) Dollars (\$ 5.00) Dollars, being the monthly payment on said shares of stock and One + 33/100 (\$ 1.33) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Five + 67/100 (\$ 5.67) Dollars, (\$ 5.00) Dollars being the monthly payment on said shares of stock and Sixty seven cents (\$ 0.67) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said Five shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said Joe Gregg and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said Joe Gregg in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Joe Gregg in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said Joe Gregg in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

Situate in Ward six of the City of Greenville, and fronting on the south side of Sullivan Street fifty eight feet with a depth of one hundred and eight feet and bounded as follows: On west by Nellie Hampton, on South by J. C. Milford, on East by Georgiana Riddy and on the north by Sullivan Street and being the same lot conveyed to me by J. C. Milford by his deed dated April 6th 1920 and recorded in volume 63, page 519 P. M. C. Office for Greenville County.
