

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Nellie J. Hampton, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, the said Nellie J. Hampton in and by my certain bond or obligation, bearing date the 1st day of July 1921, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Six Hundred + no/100 (\$600.00) Dollars,

conditioned for the payment of the full and just sum of Three Hundred + no/100 (\$300.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 1st day of July A. D. 1921 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that the said Nellie J. Hampton shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of July 1921, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum Five + no/100 (\$5.00) Dollars,

being the regular monthly installment payable on the Three + no/100 shares of stock, and Two + no/100 (\$2.00) Dollars being the monthly interest on the advance or loan, until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Four + no/100 (\$4.00) Dollars,

being the regular monthly payment on said stock and One + no/100 (\$1.00) Dollars being the monthly interest on balance due; for the next twenty months the sum of Four + no/100 (\$4.00) Dollars,

being the regular monthly payment on said stock and One + no/100 (\$1.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Three + no/100 (\$3.00) Dollars,

being the monthly payment on said shares of stock and Eighty cents (\$0.80) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Three + no/100 (\$3.00) Dollars,

Hampton and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said Nellie J. Hampton in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Nellie J. Hampton in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said Nellie J. Hampton in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

Situate in Southern part of City of Greenville on the South side of Sullivan street beginning at an iron pin on Sullivan street and running thence N. 66 1/2 W. 67 links. thence S. 20 1/2 W. 3.66 to Pinkney Latimer's line; thence S. 80 1/2 E. 56 links. thence N. 23 1/2 E. to the beginning corner and containing one-fifth of one acre, more or less, and being known as lot no. 11 of sub-division of the Emery Harrison land plat made by G. N. Southern Surveyor, March 6th. 1911 and being same lot conveyed to me by Emery Harrison, deed dated March 8th. 1911 and recorded in R. M. C. office for Greenville County in Deed Book 11 page 183, less lot over, a lot cut therefrom and conveyed by me to J. C. Milford deed recorded in Volume 35 page 168, R. M. C. office for Greenville County, South Carolina.
