

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

we O. M. Goodlett and M. H. Goodlett of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, *we* the said O. M. Goodlett and M. H. Goodlett in and by my certain bond or obligation, bearing date the 26th day of January 1922, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Four Thousand + no/100 (\$4000.00) Dollars, conditioned for the payment of the full and just sum of Two Thousand (\$2000.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 26th day of January A. D. 1922 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that *we* the said O. M. Goodlett and M. H. Goodlett shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of January 1922, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum Sixty-Three + 33/100 (\$63.33) Dollars (\$50.00) Dollars, being the regular monthly installment payable on the Twenty shares of stock, and Thirteen + 33/100 (\$13.33) Dollars being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Fifty-six + 67/100 (\$56.67) Dollars (\$50.00) Dollars, being the regular monthly payment on said stock and six + 67/100 (\$6.67) Dollars being the monthly interest on balance due); for the next twenty months the sum of _____ Dollars, (_____ Dollars being the regular monthly payment on said stock and _____ Dollars being the monthly interest on balance due); for the next twenty months pay the sum of _____ Dollars (_____ Dollars being the monthly payment on said shares of stock and _____ Dollars being the monthly interest on balance due); for the next twenty months pay the sum of _____ Dollars (_____ Dollars being the monthly payment on said shares of stock and _____ Dollars being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said 20 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said O. M. Goodlett and M. H. Goodlett and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said O. M. and M. H. Goodlett in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That *we* the said O. M. and M. H. Goodlett in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said O. M. and M. H. Goodlett in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

situated in the City of Greenville on Elford Street, and having the following notes and bounds, to-wit: Beginning on Elford Street at a stake running thence S. 45-3/4 W. 100 feet thence S. 42-1/2 E. 135 feet; thence N. 47-1/2 E. 100 feet; thence N. 42-1/2 E. 191 feet. This description being taken from the deed made by J.W. Gray, Master, to Ward Goodlett, dated February 23, 1910, recorded in Volume UUU, page 71, and being the same lot of land conveyed to O.M. Goodlett by E. Inman, Master by deed dated January 7th, 1922, to be recorded, and O.M. Goodlett, subsequently conveying one-half interest in said lot to M.H. Goodlett by deed of even date to be recorded.
