

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mary Langley, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, the said Mary Langley in and by my certain bond or obligation, bearing date the 15th day of February 1922, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Six Hundred (\$600.00) Dollars, conditioned for the payment of the full and just sum of Three Hundred (\$300.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 15th day of February A. D. 1922, according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that the said Mary Langley shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of February 1922, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum Five + 20/100 (\$5.00) Dollars (\$3.00) Dollars, being the regular monthly installment payable on Two + 20/100 (\$2.00) Dollars being the monthly interest on the advance or loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Four + 60/100 (\$4.60) Dollars (\$3.00) Dollars, being the regular monthly payment on said stock and One + 60/100 (\$1.60) Dollars being the monthly interest on balance due); for the next twenty months the sum of Four + 20/100 (\$4.20) Dollars being the regular monthly payment on said stock and One + 20/100 (\$1.20) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Three + 80/100 (\$3.80) Dollars (\$3.00) Dollars, being the monthly payment on said shares of stock and Eighty cents (\$0.80) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Three + 40/100 (\$3.40) Dollars being the monthly payment on said shares of stock and Forty cents (\$0.40) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said Three shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said Mary Langley and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said Mary Langley in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Mary Langley in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said Mary Langley in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

In the City of Greenville, near Airline Depot fronting on a forty foot street, connecting Pine + Cook Street and having a frontage on said forty foot street of 62 feet and 6 inches and a depth of 89 feet, said lot being on the corner of said forty foot street and Pine Street and consisting of two lots conveyed to me by S. J. Cassey one by deed dated December 20th. 1913, recorded in Volume 26, page 146 and one by deed dated November 19th. 1913 recorded in Volume 23, page 398, R.M.C. office for Greenville County. Said lots being more particularly described in said deeds, and is the same lot whereon I now reside.
