

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Lula J. Griffie, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I, the said Lula J. Griffie, in and by my certain bond or obligation, bearing date the 22nd day of December, 1922, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Twelve hundred (\$1200.00)

Dollars, conditioned for the payment of the full and just sum of Six hundred (\$600.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 22nd day of December

A. D. 1922 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I, the said Lula J. Griffie, shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of January

1923, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum Ten Dollars (Six Dollars,

being the regular monthly installment payable on the six (6) shares of stock, and Four Dollars

being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Nine and 20/100 (\$9.20) Dollars (Six Dollars,

being the regular monthly payment on said stock and Three and 20/100 (\$3.20) Dollars being the monthly interest on balance due); for the next twenty months the sum of Eight and 40/100 (\$8.40) Dollars,

(Six Dollars being the regular monthly payment on said stock and Two and 40/100 (\$2.40) Dollars being the monthly interest on balance due); for the next twenty months pay

the sum of Seven and 60/100 (\$7.60) Dollars (Six Dollars, being the monthly payment on said shares of stock and one and 60/100 (\$1.60) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Six and 80/100 (\$6.80) Dollars,

(Six Dollars being the monthly payment on said shares of stock and one and 80/100 (\$1.80) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said six shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said Lula J. Griffie, and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said Lula J. Griffie, in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Lula J. Griffie, in consideration of the said debt and sum of money aforesaid and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said Lula J. Griffie in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

All that piece, parcel or lot of land just outside of the City limits of the city of Greenville, on the South side of Doe street, having the following metes and bounds, to-wit: Beginning at the corner of F. P. McCarell's lot on Doe street, to a corner of a strip of land (formerly belonging to C. F. Dill) n. w. 45 ft along Doe street; Thence along line of C. F. Dill, S. W. 96 feet; Thence S. E. 45 feet to a line of F. P. McCarell's; Thence along line of F. P. McCarell's lot 96 feet to the beginning corner, and being the same lot conveyed to me by C. F. Dill by deed dated Feb. 21st, 1906 recorded in Vol. R. P. R. page 628.
