

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Vashti Thackston, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said Vashti Thackston in and by my certain bond or obligation, bearing date the 27th day of December 1922, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Five hundred (\$500.00)

conditioned for the payment of the full and just sum of Two hundred fifty (\$250.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 27th day of December A. D. 1922

according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I the said Vashti Thackston shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of December 1922

and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum of Four & 1/200 (\$4.17) Dollars (2.50) Dollars,

being the regular monthly installment payable on the 2 1/2 shares of stock, and One & 67/100 (\$1.67) Dollars

being the monthly interest on the advance (or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Three & 83/100 (\$3.83) Dollars (2.50) Dollars,

being the regular monthly payment on said stock and One & 33/100 (\$1.33) Dollars being the monthly interest on balance due); for the next twenty months the sum of Three & 50/100 (\$3.50) Dollars,

(2.50) Dollars being the regular monthly payment on said stock and One & 00/100 (\$1.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Three & 17/100 (\$3.17) Dollars (2.50) Dollars,

being the monthly payment on said shares of stock and Thirty cents (.30) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Three & 83/100 (\$3.83) Dollars,

(2.50) Dollars being the monthly payment on said shares of stock and Thirty-three cents (.33) Dollars being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said 2 1/2 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me the said Vashti Thackston and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against, the said Vashti Thackston in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto and will more fully appear.

NOW KNOW ALL MEN, That I, the said Vashti Thackston in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said Vashti Thackston in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

Beginning on North side of Nichols street at corner of Jenny Ford lot; Thence N. 14 E, 100 feet to Hornet Dogerist line; Thence N. 76 W. 50 feet to William Fisher lot; Thence S. 14 W. 100 feet to Nichols street; thence along Nichols street S. 74 E, 50 feet to the beginning corner, being same lot conveyed to me by Working Mens Saving & Loan Co, Nov. 27 1907, deed recorded in Volume W.W.W. page 32, R.M.C. office for Greenville, County South Carolina, Also: All that lot in said city, County and state aforesaid being the northwestern half of lot No. 35 of Mountain City Land & Improvement Co, deed recorded in F.F.F. page 617, fronting on an alley 43 feet with a depth of 100 feet being that part of Lot No. 35 remaining after my conveyance to J.A. Tolbert, (See deed in Vol. 24, page 100, to a part of said lot.
