

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, A. D. Robinson, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said A. D. Robinson in and by my certain bond or obligation, bearing date the 23rd day of December 1922, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Sixteen Hundred and no/100 (\$1600.00)

conditioned for the payment of the full and just sum of Eight Hundred and no/100 (\$800.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly from the 23rd day of December A. D. 1922 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I the said A. D. Robinson shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of December 1922, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum of Thirteen and 33/100 (\$13.33) Dollars

being the regular monthly installment payable on the Eight shares of stock, and 33/100 (\$5.33) Dollars being the monthly interest on the advance or loan), until there have been paid twenty monthly payments and shall for the next twenty months pay the sum of Twelve and 27/100 (\$12.27) Dollars

being the regular monthly payment on said stock and Two and 27/100 (\$2.27) Dollars being the monthly interest on balance due); for the next twenty months the sum of Eleven and 29/100 (\$11.29) Dollars,

Three and 29/100 (\$3.29) Dollars being the regular monthly payment on said stock and Two and 29/100 (\$2.29) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Two and 13/100 (\$2.13) Dollars

being the monthly payment on said shares of stock and Two and 13/100 (\$2.13) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Nine and 07/100 (\$9.07) Dollars,

One and 07/100 (\$1.07) Dollars being the monthly payment on said shares of stock and One and 07/100 (\$1.07) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said Eight shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said A. D. Robinson and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said A. D. Robinson in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said A. D. Robinson in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said A. D. Robinson in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

*On Greene Avenue in the city of Greenville, having the following metes and bounds, to-wit:-
Beginning at corner of lot of James Moore and Peretta McKins running thence with Greene Avenue S. 26-45 W. 50 feet to corner of Williams lot; thence S. 62-10 E. 179.8 feet to Crosskeys Alley; thence with said alley N. 26-35 E. 50 feet to Moore and McKins corner; thence with said Moore and McKins lot N. 62-10 W. 178.75 feet to the beginning corner, being the same lot of land conveyed to me by deed from William Donald, Dr. dated December 1922, to be recorded.*
