

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Alice D. Oyley, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said Alice D. Oyley in and by my certain bond or obligation, bearing date the 15th day of May 1923, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of One thousand & no/100 (\$1000.00)

the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Seven & 67/100 (\$7.67) Dollars (5.00) Dollars, being the regular monthly payment on said stock and Two & 67/100 (\$2.67) Dollars being the monthly interest on balance due); for the next twenty months the sum of Seven & no/100 (\$7.00) Dollars, (5.00) Dollars being the regular monthly payment on said stock and Two & no/100 (\$2.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Six & 33/100 (\$6.33) Dollars (5.00) Dollars, being the monthly payment on said shares of stock and One & 33/100 (\$1.33) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Five & 67/100 (\$5.67) Dollars, (5.00) Dollars being the monthly payment on said shares of stock and Sixty-seven cents (0.67) Dollars, being the monthly interest on balance due).
