TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, D. H. McCarbelle, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I the said D. H. McCarbelle in and by my certain bond or obligation, bearing date the 2nd day of May 1923, stand firmly held and bound unto

THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Fifty - five hundred and no/100 (\$5500.00)

conditioned for the payment of the full and just sum of Twenty - seven hundred and Fifty (\$2750.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 2nd day of May 1923

A. D. 1923 according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I the said D. H. McCarbelle shall pay, or cause to be paid, to the said

Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of May 1923, and on the 20th, or before the end of each month thereafter, for twenty successive months, the sum Twenty - five and 8/100 (\$25.83) Dollars (\$27.50)

being the regular monthly installment payable on the 27 1/2 shares of stock, and Eighteen and 33/100 (\$18.33) Dollars

being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty - seven and 17/100 (\$27.17) Dollars (\$27.50)

being the regular monthly payment on said stock and Eighteen and 67/100 (\$18.67) Dollars being the monthly interest on balance due); for the next twenty months the sum of Thirty - eight and 50/100 (\$38.50) Dollars,

(\$27.50) Dollars being the regular monthly payment on said stock and Eleven and no/100 (\$11.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Thirty - four and 83/100 (\$34.83) Dollars (\$27.50)

Dollars being the monthly payment on said shares of stock and Seven and 33/100 (\$7.33) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Thirty - one and 17/100 (\$31.17) Dollars,

(\$27.50) Dollars being the monthly payment on said shares of stock and Three and 67/100 (\$3.67) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said 27 1/2 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said D. H. McCarbelle and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said D. H. McCarbelle

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had full more fully appear.

NOW KNOW ALL MEN, That I, the said D. H. McCarbelle in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said D. H. McCarbelle in hand well and truly paid by the said THE CAROLINA

LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

In the First Ward of the City of Greenville on the South corner of Frank Street and Norwood Avenue (Formerly Key Street) and having the following metes and bounds, to-wit:- Beginning at a stake on the corner of Frank Street and Norwood Avenue; thence along said Frank Street S. 56 W. 60 feet to stake; thence S. 34 E. 137 feet to iron pin (now fence); thence N. 56 E. along said fence 60 feet to iron pin on Norwood Avenue; thence N. 34 W. 137 feet along Norwood Avenue to the point of beginning, and being the same lot conveyed to O.E.
