being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty-three + 20/100 (23.00) Dollars (15.00) Dollars,

being the regular monthly payment on said stock and Eight + 20/100 (8.00) Dollars being the monthly interest on balance due); for the next twenty months the sum of Twenty-one + 20/100 (21.00) Dollars,

(15.00) Dollars being the regular monthly payment on said stock and Six + 20/100 (6.00) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Nineteen + 20/100 (19.00) Dollars (15.00) Dollars,
