

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, That, I, D. H. Holybee, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, I, D. H. Holybee the said D. H. Holybee in and by my certain bond or obligation, bearing date the 28th day of June 1923, and hereby held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Six Hundred Fifty + no/100 (\$650.00) Dollars, conditioned for the payment of the full and just sum of Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 28th day of June A. D. 1923, according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that I, D. H. Holybee the said D. H. Holybee shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of June 1923, and on the 20th, or before the end of each month thereafter for twenty successive months, the sum

Seven + 33/100 (\$7.33) Dollars (6.50) Dollars, being the regular monthly installment payable on 6 1/2 shares of stock, and Four + 33/100 (\$4.33) Dollars being the monthly interest on the advance of loan, until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Three + 47/100 (\$3.47) Dollars (6.50) Dollars, being the regular monthly payment on said stock and Three + 47/100 (\$3.47) Dollars being the monthly interest on balance due; for the next twenty months the sum of Seven + 10/100 (\$7.10) Dollars (6.50) Dollars being the regular monthly payment on said stock and Two + 60/100 (\$2.60) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Eight + 23/100 (\$8.23) Dollars (6.50) Dollars, being the monthly payment on said shares of stock and One + 73/100 (\$1.73) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Seven + 37/100 (\$7.37) Dollars (6.50) Dollars being the monthly payment on said shares of stock and Seven cents (\$0.07) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter surrender to the Company the said 6 1/2 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said D. H. Holybee and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said D. H. Holybee in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said D. H. Holybee in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to me the said D. H. Holybee in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

About two and one-half miles from Greenville Court House near the Anderson Road known as Lot No. 32 on plat of lands of N. B. Bates, made by R. C. Dalton, Engineer, and recorded in office of R. M. C. for Greenville County in Plat Book F, page 32, beginning at an iron pipe on the northeast corner of Honour and Cobb streets and running thence with Honour Street S. 55-40 E. 50 feet to stake corner of lot No. 30, thence N. 48-30 E. with line of lot No. 30, 150 feet to stake point corner of lots 30, 31, 32 and 33 thence with line of lot No. 33 N. 55-40 W. 50 feet to stake on Cobb Street and thence with Cobb Street S. 48-30 W. 150 feet to the beginning corner and being the same lot conveyed to me by N. B. Bates by deed dated day of June 1923, to be recorded.
