

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, W. R. Thompson, of Greenville, in the County of Greenville and State of South Carolina, SEND GREETING:

WHEREAS, W. R. Thompson the said W. R. Thompson in and by my certain bond or obligation, bearing date the 25th day of September 1928, stand firmly held and bound unto THE CAROLINA LOAN AND TRUST COMPANY, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the penal sum of Five hundred Dollars,

conditioned for the payment of the full and just sum of Thirty-eight Hundred Fifty Dollars, (3850.00)

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 25th day of September A. D. 1928

according to the provisions of the Charter, By-Laws, Rules and Regulations of said Company, in manner and form the following, that is to say, that W. R. Thompson shall pay, or cause to be paid, to the said Company, or its certain attorneys, successors, or assigns, at Greenville City aforesaid, monthly, on the 20th day, or before the end of the month of October 1928, and on the 20th, or before the end of each month thereafter, for twenty successive months the sum Sixty + 96/100 (\$60.96)

Dollars (60.96) being the regular monthly installment payable on the Thirty-eight shares of stock and Twenty-two + 46/100 (\$22.46) Dollars

being the monthly interest on the advance or loan), until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Eighty-six + 47/100 (\$86.47) Dollars (86.47)

being the regular monthly payment on said stock and Seventy-nine + 97/100 (\$79.97) Dollars being the monthly interest on balance due); for the next twenty months the sum of Eighty-one + 97/100 (\$81.97) Dollars, (81.97)

Dollars being the regular monthly payment on said stock and Thirteen + 47/100 (\$13.47) Dollars being the monthly interest on balance due); for the next twenty months pay the sum of Forty-seven + 58/100 (\$47.58) Dollars (47.58)

Dollars being the monthly payment on said shares of stock and Sixty + 98/100 (\$60.98) Dollars being the monthly interest on balance due); for the next twenty months the sum of Forty-two + 99/100 (\$42.99) Dollars, (42.99)

Dollars being the monthly payment on said shares of stock and Four + 49/100 (\$4.49) Dollars, being the monthly interest on balance due).

Each of the above payments to be made on the 20th, or before the last day, of each month, and shall thereafter, surrender to the Company the said 38-1/2 shares of stock and the certificate thereon, the amount at such time paid on the said shares by me to be credited as a payment upon the advance or loan made me, the said W. R. Thompson and shall pay or cause to be paid, all fines which may be duly imposed upon, or charged against me, the said W. R. Thompson in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said bond or obligation, and the conditions thereon, written reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said W. R. Thompson in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE CAROLINA LOAN AND TRUST COMPANY, according to the condition of the said bond or obligation, and also in consideration of the further sum of FIVE DOLLARS, to the said W. R. Thompson in hand well and truly paid by the said THE CAROLINA LOAN AND TRUST COMPANY, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and, by these Presents, do grant, bargain, sell and release unto the said THE CAROLINA LOAN AND TRUST COMPANY, all that tract or parcel of land situated in the County of Greenville State of South Carolina, and described as follows:

(1) all that certain lot of land situate in Fox Mill Village on Pinckney Street and being designated as Lot No. 14 of the "Hamnett Land" as shown by plat of H. A. Hudson dated May 14, 1900, recorded in Deeds Book A.H.H., at page 835 and having the following courses and distances:

Beginning on Pinckney Street at the corner of Lot No. 18 thence running with Pinckney St in an easterly direction 100 feet to the corner of Lot No. 20 thence with the line of Lot No. 20 southerly 190 feet to a 10-foot alley, thence with said alley in a westerly direction 100 feet to the line of Lot No. 18, thence with the line of that lot in a northerly direction 190 feet to the beginning corner, being the same lot conveyed to me by Susan Childress, May 25, 1926, by deed recorded in Vol. 106 at page 546, R.M.C.
