Beginning at an iron pin on Washington Street and running thence with Washington Street
S. 67 E. seventy-seven (77) feet, ten (10) inches to an iron pin; thence N. 27 E. one
hundred and forty (140) feet to a stake; thence approximately N. 67 W. seventy-seven
