all that piece, parcel, tract or lot of land situated in Greenville

Township, Greenville County, State of South Carolina, near the City of Greenville, in the subdivision known as

Cherokee Park and being known and designated as Lot #72 on the plat of said subdivision recorded in Plat Book "C", at page 96, and having the following metes and bounds, to-wit: Beginning at an iron pin on the North side of Cateechee Road, joint corner of lot of Rita B. Hart and the lot herein conveyed; thence with the northern side of Cateechee Road S. 75-45 W. 60 feet to an iron pin, corner of lots Nos. 71 and 72; thence with joint line of said lots N. 14-15 W. 188 feet to an iron pin; thence N. 75-45 E. 60 feet to an iron pin, corner of Lot of Rita B.
