Geer, Treasurer

all that piece, parcel, tract or lot of land situated in Greenville

Township, Greenville County, State of South Carolina, known and designated as Lot No. 3 on plat of E.N. Green property recorded in R.M.C. Office for Greenville County in Plat Book E, page 287, and having the following metes and bounds according to said plat: Beginning at a stake on the West side of Keowee Avenue 100 feet from corner of Keowee Avenue and Saluda Avenue and running thence with Keowee Avenue S. 26-50 W. 80 feet to stake; thence N. 62-50 W. 172 feet to stake on 15 foot alley; thence with said alley N. 26-50 E. 80 feet to stake; corner lot No. 1; thence with line of lots 1, 2 and 4, S. 62-50 E. 172 feet to the beginning. The above lot is a portion of lot No. 12 and all of lot No. 13 of South Cherokee Park as shown on plat recorded in Plat Book A, page 130, the portion of lot No. 12 having been conveyed to E.N.
