Near City View known as lot no. 43 in a subdivision known as City View Annex, said lot being specifically described as follows: Beginning at a corner of lot #42 in said subdivision and running thence along line of lot #42 S. 31-30 E. 456.8 feet to pin thence S. 46-00 W. 100 feet to pin thence along line of lot #44 403 feet to Nichols street thence along said Nichols Street 100 feet to the beginning corner.
