All that certain lot or parcel of land situate lying and being in Greenville Township, County and state aforesaid near the city of Greenville, known and designated as portions of Lots Nos. 77 and 78 of The subdivision known as Augusta circle, as shown on a plat of record in the P. M. C. office for Greenville County, in the Plat Book "F" page 23 and having according to said plat the following metes and bounds.

Beginning at an iron pin on the western side of Tomasse Avenue, which iron pin is 227 feet North of the Northwest corner of Tomasse Avenue and a 15-ft street; thence N. 71-35 W. 150 feet to an iron pin in line of lot No. 104; thence N. 21-35 E. 57 feet to an iron pin in line of lot No. 106; thence N. 21-35 E. 57 feet to an iron pin in line of lot No. 105; thence S. 71-35 E. 150 feet to an iron pin on Tomasse Avenue, which iron pin is 284 feet North of The North west corner of Tomasse Avenue, and a 15 ft. street thence with Tomasse Avenue, S. 21-35 W. 57 feet to the point of beginning.
